Questions Related to Funding
5) Do you support the Promise Act and would you advocate for its passage with the state legislature?

Worcester needs and deserves more funding to reach an adequate level of funding. The proposed new funding will make a significant difference for our students.

6) State spending requirements enable local communities to spend more than the minimum required by the Chapter 70 Foundation formula. Since most local communities do spend more than required to address the educational needs of their students, on average, local communities spend over 25% above their required allocation. Worcester typically funds right at the minimum required by the Chapter 70 Foundation formula (give or take roughly 1%). ## 6) Explanation of response (optional)

As a member of the school committee, it is our responsibility to advocate for more funding for education. At the same time, I also understand that the city has financial constraints with needs in many areas. The city has committed significant resources in debt service for the construction of new school buildings. The new state funding will require more funds from the city. I will state that City Manager Augustus understands the importance of funding for public education and has been willing to stretch the funding.

7) Facing fiscal shortfalls as a result of the Great Recession, in 2010, the City of Worcester became one of the few municipalities in the state that began taking a 3% indirect of the state and federal grants that pass through City Hall. This amounts to over a million dollars that is designed to cover the costs of developing and administering the grants (which in Worcester are all handled by the school department). Would you, if elected to the school committee, advocate for City of Worcester to continue to take this 3% indirect?

## 7) Explanation of response (optional)

This was an inappropriate move to take more funding from the schools without any legitimate justification. We fought this move for many years with the city and included the state in these discussions and rulings. City Manager Augustus has reduced these indirect cost recoveries from 3% to a lower rate, but not completely back to 1%. The city is already taking a "credit" for the administrative support of city offices, thus there is no need to "double dip" with these indirect charges.

I am hopeful that Ms. Perez can begin to implement these trainings, but a commitment to diversity and inclusion requires the full support of the institution.
