## 5) Do you support the Promise Act and would you advocate for its passage with the state legislature?

YES, YES AND YES! The new bill is called the "Student Opportunity Act" ... The Student Opportunity Act bill modeled after the MTA Promise Act and passed by the State Senate by a 39 to 0 vote is one more opportunity for the state to get it right. This bill will fulfill the recommendations stated in the 2015 foundation budget review commission report for it addresses the needs of our most underserved students in the Gateway cities. It is the most significant update to the funding formula since it was established in 1993.

6) State spending requirements enable local communities to spend more than the minimum required by the Chapter 70 Foundation formula. Since most local communities do spend more than required to address the educational needs of their students, on average, local communities spend over 25% above their required allocation. Worcester typically funds right at the minimum required by the Chapter 70 Foundation formula (give or take roughly 1%). If you were elected to school committee would you advocate for the city to spend 10% or more above the required foundation formula even if that means the city would have to secure additional revenue?

## 6) Explanation of response (optional)

It's easy to say yes but is it possible? Gateway cities such as Worcester have many expenses and needs. We must continue to work with the City Manager and be realistic on what the City can afford to pay for our schools. I would advocate for the city to give the schools 5% above the minimum requirement of the Foundation formula. 7) Facing fiscal shortfalls as a result of the Great Recession, in 2010, the City of Worcester became one of the few municipalities in the state that began taking a 3% indirect of the state and federal grants that pass through City Hall. This amounts to over a million dollars that is designed to cover the costs of developing and administering the grants (which in Worcester are all handled by the school department). Would you, if elected to the school committee, advocate for City of Worcester to continue to take this 3% indirect?

#### 7) Explanation of response (optional)

I have spoken on the floor at City Hall about this and advocated for the City to reduce the percentage. They have lowered the percentage to 2% but I'd like to see it reduced to 1%. We also need a better financial agreement with Medicaid funds. Here's how it works! The Worcester Public Schools collects \$3.2 million from the federal government for providing certain medical and occupational and physical therapy services to Medicaid eligible students. These are services that are required to be provided to the students as part of their school day. Because of an antiquated state law, none of these funds actually goes back to the Worcester Public Schools but the funds are placed in the city's general fund to be used as part of the city's budget. On the other hand the city has continued to support the schools with new school construction.

So based on all the research in the past twenty years why aren't more districts not changing their starting time? It's the same reasons that were articulated at the standing committee meetings in our city ... disruption in child care, for in many cases older children care for younger children when they get out of school or even before school, the challenge of coordinating interscholastic activities and sports with other districts, students with after school jobs and the biggest reason is the financial aspect of what it would cost in transportation. Many of the high schools start their day at 7:20 a.m. Thus, in an attempt to save money on transportation can all the times within our district be moved up 30 minutes? It's something to think about and explore?

Once again we as a community need to make healthy policy decisions for all students. Is it possible that these problems can be worked out? We know the benefits from the research but at the moment we are stuck in neutral. Let's look at the obstacles and see if they can be solved. I'd like to see administration come up with some alternatives or at best start a pilot program at one high school and see how it works. Let's examine our options and not just sweep the item under the rug or do what we have done for the last fourteen years – ignore the problem.
