4) Explanation of response (optional)

Let's first note that "standards" and "curriculum" are not the same thing, so I'm concerned about this question's direction. Standards are what is taught; curriculum is when and how. Curriculum is and remains a local decision.

We're seeing what happens when 'flexiblity" comes to health education in Worcester now; no, I don't want to see that in English, history (which has had an excellent recent revamp of standards that really encompass so much more that what is being done in Worcester!), and the like. There are things that every child in Massachusetts should know, and that does need to be determined somewhere. I attend the meetings at which that happens. Given the exhaustive process (currently going on with arts education) that involves hundreds of practictioners (including many many classroom teachers) and a significant public comment period, I'm comfortable with it.

Worcester typically funds right at the minimum required by the Chapter 70 Foundation formula (give or take roughly 1%). 7) Facing fiscal shortfalls as a result of the Great Recession, in 2010, the City of Worcester became one of the few municipalities in the state that began taking a 3% indirect of the state and federal grants that pass through City Hall. This amounts to over a million dollars that is designed to cover the costs of developing and administering the grants (which in Worcester are all handled by the school department). Developing the grants is handled by the school deparment; administering the grants does have some degree of municipal involvement, given that the schools don't write their own checks, for example. I was on the Committee during the period in which we fought about this, and it would be easy to give a "no" answer on this. I will say, though, after myriads of years in which this was one of the only audit findings, I genuinely do not believe this to be the biggest issue with WPS use of grants right now. I'm much more concerned with School Committee oversight on actual spending.
