Questions related to curriculum

1) Do you approve of the Worcester School Committee's vote in May 2021 to implement the comprehensive sex education curriculum, "Rights, Respect, Responsibility," for Worcester Public Schools.

Worcester is well overdue to have a comprehensive, citywide curriculum. For too long, the access students had to health education was entirely dependent on whom they have had as a teacher (some of whom are excellent, some of whom are not). Ensuring your students receive this education can literally save their life, as I said twenty years ago as an English teacher. Bringing down the teen pregnancy rates, bringing down the rates of STDs, providing resources for students who may face sexual assault, lowering the chances of our students committing sexual assault, and providing the supportive environment our LGBTQIA students deserve are all consequences I am looking forward to seeing from this decision.

2) Would you advocate to the State Legislature for the elimination of the 10th grade MCAS as a graduation requirement for high school students in Massachusetts?

...because it isn't that simple.

Our state ESEA plan includes tenth grade MCAS as part of the plan. That is what ensures we have access to our federal Title grants. Changing the state portion of this doesn't solve the larger equation of the federal law, which was advocated for by civil rights organizations (yes, really). This is a complicated question.

3) Would you advocate to the State Legislature for the elimination of high stakes standardized tests, like the MCAS, to evaluate school performance (and put in place alternative ways to evaluate schools and educator performance)?



I first think it's important to note that educators aren't evaluated by student performance; that was explicitly dropped several years ago. I'd be interested in a conversation that really looks at what we want schools to do, and then discusses how to evaluate that. I don't, quite honestly, see that discussion happening much of anywhere right now. I see a lot of shouting.

4) Would you work to allocate District resources away from some standardized curriculum and software purchases to provide more autonomy for schools and teachers to decide what learning tools and materials they want to include in their classrooms?

On one hand, I made the motion that moved the money away from further early literacy PD that doesn't touch the classroom (as teachers weren't attending) on a program that I find of questionable utility. On the other hand, we have a very high rate of mobility, and I do think that having the same set of resources used across the district is very very helpful with students who we know are going to be switching schools.
